(A) Approval of TEQIP-II Committees

(B) Approval of Work done so far

- (i) The expenditure occurred so far till 30<sup>th</sup> June 2014 (annexure **2**) to perform different activities against various heads of TEQIP II project was brought into the knowledge of BoG for approval.
- (ii) Dr. G. P. Khare (Associate Professor) registered for Ph. D. programme in Civil Engg. from session 2010-11 at Shri Jagdishprasad Jhabarmal Tibarmal University, Rajesthan and Mr. S. K. Dekate, (Senior Lecturer) registered for Ph. D. programme in Electronic & Telecommunication Engg from session 2012-13 at Dr. C.V.Raman University, Bilaspur were permitted earlier by Principal and it was brought into the knowledge of BoG for approval.
- (iii)Mr. T. P. Singh, (Contract Lecturer) registered for M. Tech. programme in Electronic & Telecommunication Engg from session 2013-14 at Kernataka State University, Mysore was permitted earlier by Principal and it was brought into the knowledge of BoG for approval.

- (vii)A Purposed plan (annexure 4) for Industry training to faculty / staff / student and related expenditure.
- (viii) The Institutional Management Capacity Enhancement training for Faculty/Staff time to time as per instructions received from NPIU/SPFU/ IIMR / any other agency.

- (ix) The remedial classes to weak students for backlog subject in evening time and Remuneration to faculty for remedial classes for minimum 5 students.
