A short presentation on status of TEQIP-II progress of institution for approved plan of previous meeting was made by Dr. M.R. Khan, TEQIP-II Coordinator before honorable members of BOG. There after the final agenda was kept for discussions and approval of honorable members.

After third BOG meeting, various activities as per approved plan have been carried out on different heads of TEQIP-II project for the benefit of students and institution development.

The expenditure occurred to till date 2016 (annexure 1) to perform different activities in TEQIP-II project is being kept before BOG for their kind approval. As per the agenda, the work progress details are given below:

Timo installment of its 500 CF, had been received in January 2016 and hence various procurement activities are processed and carried out from the same and no expenditure till date has been booked from the approved allocations from the Development fund. It is proposed that either the allocation is exhausted or time span is lapsed, the remained expenditure shall be booked from the approval as obtained in the last meeting of the BOG.

However the furnishing part for various department and library, of the earlier approval shall be carried out by the institution following the procurement manual guidelines of the NPIU as there is no provision left for the same in the received third installment of TEQIP II.

# 1.2 Budgetary allocations for Fee of NBA accreditation

It is mandatory for the continuation of TEQIP-II project for the Institution to be NBA accredited for at least 55% of the total program. The Institute had applied for 5 out of total of 8 programs for NBA accreditation and submitted the registration fee of Rs. 1, 14,000 and course fee Rs. 14, 82,000 from development fund (Annexure 2).

#### 1.3 Budgetary allocations for Fee of NBA Training

A workshop on "Preparing for NBA Accreditation" was successfully organizes by NITTTR Bhopal from 17th to 21th August, 2015 in the Institution. Total of 21 participants including the entire Regular and contractual faculty attended the workshop. For this purpose the payment of Rs. 2, 04.761 have been done to NITTTR, Bhopal.

#### 1.4 Budgetary allocations for Library Books from Development Fund

Rs. 20 lacs were allocated and about Rs. 1.48 lacs have been utilized so for And for remaining amount the procurement process is in progress. (anexure3)

Taking into consideration the timeline and guidelines / directions issued by the NPIU and SPFU from time to time the institution has continued to implement the TEQIP II project in context to all activities (as shown in the table annexure 8) including the largest part of procurement.

#### Procurement Status

It was first priority to provide modern and latest technology, to learners and to make vasilable the same, it was plan to procure laboratory equipments and to develop IT infrastructure for enhanced learning, computing with online library management system facilities. The salter IT Infrastructure is now in place and operative with VPF-18 to being made operative with VPF-18 to being made operative with very latest the procurement process has already been initiated. For library automation and e-Dools installation process is going on. Similarly for modernization and bridging the gap procurement of various laboratories equipments of all the teaching departments are per the NPIU guidelines.

The order for procurement of twenty seven packages of IT Infrastructure, Library automation/equipments/goods for Rs. 2, 94, 69,041 has been placed till date. The bill has been passed for five package costing Rs. 73, 48,362 and bills for the rest of the amount Rs. 2, 21, 20,679 shall be cleared as soon as process will be completed. (annexure 9)

For the utilization of the remaining amount process has already been initiated of estimated value Rs. 1, 62, 75,000 and shall be completed within the timeline provided by the NPIU and SPEU. (annexure 9)

# 2.3 Proposed budgetary allocation for Solar based High Mast light, solar street Light and IKVA SPP for power backup for the backbone and surveillance Network.

It is here by proposed to approve the budgetary allocation of Rs. 24.5 lacs for this proposed work from the development fund. However the Institution shall limit the expenditure as per the applicable subsidies offered by the Government through CREDA.

# 2.4 Proposed budgetary allocation for Library Furnishing, Interior and Facility Extension

A very important thrust area for the Improvement in teaching training and learning facilities, as per TEOP II stude component 1.1, is the modernization and E- enabled library management system. In line with the guidelines issued for the project ON LINE LIBRARY MANGEMENT SYSTEM has been ordered and is likely to be completed by the start of the next session it., July 2016. Library is the soul of any academic institution and shall be available with good academic and reading, environment along with the hard bound and e learning resources. There is a scope of work in the library in regard to the restructuring of physical space, furnishing, interior and facility extension in order to avail the facilities enhancement due the modernization of the library and also to improve the academic environment of the library. For this an estimated amount of Rs. 50 lace is required for the restructuring, furnishing (racking, reading room, exaccssing, and student facility esc.). Interior false ceiling and flooring with window partiling partitioning etc.) and Facility extension (administration of on line library management system, photo copying and reprographic secretor etc.)

Hence it proposed to allocate the estimated amount of Rs.50 lacs for the Library Furnishing, Interior and Facility Extension from the development fund.

# 2.5 Proposed budgetary allocation for Air Conditioners and potable water dispensing Systems (Water filters, Purifiers and water cooling systems)

A lot of laboratories equipments, computer systems, server room equipments for IT Infrastructure, video conferencing are procured or in the process of procurement, which needs air conditioning systems for their operations. The same is not allowed through TEQIP-II project as per the procurement manual. Hence it is proposed to install 30 no. of 11.6 to an ir conditioning systems, for which the estimated expenditure is Rs. 10.50 lacs and same is proposed for the approval.

There is an urgent need of potable water dispensing Systems (Water filters, Purifier about 1500 students and about 400 staff and visitors, Maribale systems are insufficient to cater for about 1500 students and about 400 staff and visitors, Moreover three new departmental buildings have been completed and one more hostel is soon to be completed. In light of the our justification it is proposed to insufal 30 potable water dispensing Systems (Water filters, Purifiers and water cooling systems) in the various Institutional buildings and hostels as well. It is estimated that a unit rate it is 4,0000 new water dispensing Systems)

So it is proposed to allocate Rs. 12 lacs from the development fund for the installation of potable water dispensing Systems (Water filters, Purifiers and water cooling systems)

#### 2.6 Proposed budgetary allocation for Server room furnishing.

The soul of the IT infrastructure is the server room which is now equipped with 8 data and facility server, one router, one frewall, layer 3 and layer 2 swiches, which are not only costly but also sensitive to the dust and temperature. The utmost requirement is not only air conditioning for their operations but has to proper placement on tables and racks with minimum of dust and humidily. As such an estimated amount of Rs. 50 lacs is proposed for false ceiling, flooring, furnishing, window paneling, etc. for this work from Development fund.

### 2.7 Video conferencing room interior and furnishing.

As per the NPIU guidelines every participating institute have to set up Facility of doce Conferencing within the institution for the Technology enabled learning. The required equipments for the same have been processed from TEQIP II fund. The remaining work for room preparation, furnishing, and interior, has to be done from development fund as as to create such facility for about 20 seats. An estimated amount of Rx. 100 lacs is proposed for room preparation, furnishing, and interior, etc. for this work from Development fund.

# 2.8 Minor modification in constitution of TEQIP-II committees.

In the 6° JRM held at New Delhi from 1" to 11" March 2016, the last session was especially declined to the improvement in the transition rate. As a consequence we need to strengthen the Finishing School cell to improve the transition rate hence it is proposed that the First year in charge Mr A K Bose and in charge for Communication skill Dr, Avinash Tripitati are proposed to the inducted of the cell replacing Mr. Tampusy Shrivatave (Mechanical engineering).

2.9 Proposal for permission of Ph.D. program for the next coming session of Shri S.K.Prajapati Asst. Professor in Civil Engineering and Shri T.P.Singh Asst. Professor (Contract) in Electronics and Telecommunication Engineering.

For the faculty development and qualification improvement and research enhancement, entire with the permission of BOO Mr. of E. Khare and Mr. St. Dekate had submitted their Ph.D. Thesis. Also in the last BOG two faculties namely Mr A.K.Bose and Mr. St. Dekate had Mr. P. Mishra has been permitted for Ph.D. and both have got admission for the same. It is proposed that the remaining two faculties Mr. S.K.Prajapati Asst, Professor in Crist Engineering and Shri T.P.Singh Asst. Professor in Crist Testing and Shri T.P.Singh Asst. Professor (Contract) in Electronics and Telecommunication Engineering are to be permitted for Ph.D. program for the next coming session.

Previously Institution had received a grant of Rs-2.00 Crore and in Previous BOG Meeting as per FNR of August 2015 a work worth of Rs-1,91,06-054 had executed, Further Third Installment of Rs. 5.00 Crore had received in January 2016 for activities under TEQIP-II. The different kind of activities will be carried out in all nine heads under TEQIP Illy NPIFU and State Government.
